Intro

EREF Small Hydropower Chapter

The European small hydropower industry is considered to be a world leader, able to build tailor-made hydropower facilities all around the world. European hydropower equipment manufacturing competence accounted for an estimated two-thirds of the world market.

The Small Hydropower Chapter of the European Renewable Energies Federation (EREF) represents the small hydropower sector at EU level. EREF and its members aim to secure and enhance small hydropower's place as an equally important contributor to Europe's renewable energy mix and to create business opportunities for the many small and medium-sized hydropower producers. The Chapter hosts and moderates several networks of hydropower associations and industry stakeholders.

EU Small Hydropower Industry Initiative

EREF, in cooperation with partners from the EU project HYPOSO (<u>https://www.hyposo.eu/en/home/</u>), initiated the *EU Small Hydropower Industry Initiative* which focusses on the involvement of and information about the European industry and its technological leadership.

The initiative results in the set-up of a complete information package that includes an overview of the European small hydropower industry and its products, services, and innovations. This package serves as a basic tool for the promotion of European equipment producers, project developers and investors abroad. It should also help EU decision-makers to create better framework conditions for the domestic small hydropower sector.

1. Overview of the EU Small Hydropower Industry

EREF and its members and partners are in the process of developing the first comprehensive dataset of the European small hydropower industry, which currently does not exist.

1.1 Stakeholder List

This comprehensive list of European small hydropower stakeholders includes hydropower equipment producers, project developers and investors. It is a broad database with publicly available information of the stakeholders including:


